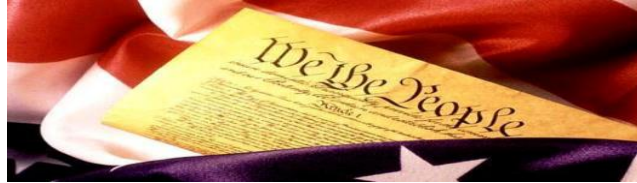




## **A U.S. Article V Constitutional Convention Citizen Ballot**

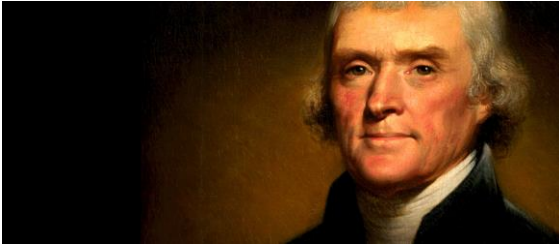

And as per Article V of the U.S. Constitution, when a majority of voters from 38-States mail in their ballots, the Democracy Amendment will be ratified.

## **Finishing America's Revolution for Democracy With verifiable Ballots and not Bullets.**

Most Americans believe the USA is already a Democracy, because they hear this Orwellian deception daily from elected officials and all of the corporate news networks. The U.S. Republic has proven to be catastrophically dysfunctional for the American people, and all life on the only planet in the Universe that sustains life, because it is a government of, by and for the wealthiest individuals and multinational oil, chemical, pharmaceutical and financial corporations, whose lobbyists have allowed them to make vast fortunes by legally mass-producing trillions of gallons of the most toxic oil-based chemicals and radiological poisons known. Given such a time-sensitive State of Emergency now exists for our country, and our planet, a majority of American voters must be made aware of their most important Constitutional power to ratify this 28th Democracy Amendment with the Article V Citizen Ballot that can be downloaded as a verifiable paper ballot (unlike the votes in past U.S. elections) from the DemocracyAmendmentUSA.org website. Once the majority of citizens in three-fourths of the States (i.e., 38 States) mail their signed paper ballots to their respective Secretary of State, where they can be verified, counted and archived, the Democracy Amendment will become law. The U.S. Citizens Congress of registered voters will then be in charge -- a "Universal Mind" of over 60 million citizens -- at which point the majority will have finished the American Revolution for Democracy that formally began in 1776. The majority will then be "deciders" rather than "observers," who can then shift from the unsustainable and highly-toxic Oil Economy to a real majority rule Democracy and Solar Hydrogen Economy that is outlined on the PhoenixProjectFoundation.US website.
